The INSETA in Partnerships with its Research Chair DUT invites applicants to be funded towards their Honours studies. The bursary is funded by the Insurance Sector Education and Training Authority (INSETA). The purpose of this funding is to promote research in the insurance sector and support INSETA's research agenda.

## Potential applicants must meet the following eligibility criteria to be considered for funding:

- All applicants must be South African citizens
- The area of study must be of relevance to the insurance sector.
- Must not have received any other bursary funding, including NSFAS.

### Applications will be accepted from Employed Workers (All ages) and Unemployed Youth (Under the age of 35):

- Unemployed Youth applicants must be currently registered at DUT
- Workers must be employed within the insurance industry

#### Areas of study to qualify for funding:

The areas of study that will be eligible for funding include, but are not limited to:

- Information Technology & related;
- Digitalization, Al and 4IR;
- Cybersecurity in the Insurance sector;
- Other finance and insurance related qualifications may be considered for funding.

- Certified ID document and Copies of previous Qualifications and Transcripts

For Insurance sector Employed Applicants:

- Proof of Employment with an Insurance Company
- Certified ID document and Copies of previous Qualifications and Transcripts

NB. If your company is not yet registered with INSETA, your HR will need to contact INSETA Skills Division to register (at no cost) with us in parallel with your application submission to DUT.

#### \* \* Conditions of the Award:

- If successful, applicants will be expected to sign a Contract and a Conditions of Grant Agreement adhering to the rules and conditions of the award.
- Only Tuition Fees will be paid for the full one-year program, all other expenses will be for the applicants own account.
- Applicants must provide a Statement of Results throughout their studies as a condition of the award.
- Applicants are expected to fully complete studies within the minimum required timeframe of I year for the Honours programme.
- Applicants must engage in the activities of the Research Chair such as attending and engaging in research seminars, colloquiums, workshops and conferences. They are also expected to attend any research workshops that will support them in their studies, organized by the Research Chair as part of the bursary award.
