

ADVERTISEMENT TO PUBLIC TVET COLLEGES TO APPLY FOR STUDY BURSARIES FUNDING FOR LECTURERS

The INSETA hereby invites active INSETA-Accredited Public TVET Colleges to apply for bursaries (two lecturers per college) on behalf of TVET Lecturers to study (or studying) at any South African Public Higher Education Institution (PHEI). The lecturers must be registered and/or studying toward an Insurance- or Finance-related SAQA-registered qualification.

Conditions to Note:

1. Only INSETA-Accredited Public TVET Colleges that have been actively training learners in 2020/2021 on INSETA learning programmes are eligible to apply on behalf of Lecturers.
2. INSETA will contract with TVET College and in-turn TVET College will manage the bursary funding, administration and reporting on behalf of Lecturers.
3. Lecturer bursaries will be approved subject to compliance with the INSETA criteria on bursaries for workers and the availability of funds.
4. Only 2 lecturers per TVET College will be funded.

Note:

1. No applications received directly from lecturers will be considered.
2. No late applications from TVET Colleges will be considered
3. Applicant TVET Colleges must complete the following documents and submit them to INSETA:
 - I. Fully completed application form (authorised signatory sign-off)
 - II. Fully completed lecturers' list
 - III. Attachments:
 - Certified copy of learner ID
 - Signed proof of employment by the TVET College (letter/contract)
 - Proof of lecturers' registration with Public Institutions

DETAILS	BURSARIES FOR PUBLIC TVET COLLEGE LECTURERS
Definition	INSETA will fund bursaries for lecturers registered for studies NQF Level 6 to NQF Level 8 at any recognized Public Institution of Higher Learning.
Closing Date	1st October 2021
Eligibility Criteria for Workers/Lecturer	Beneficiaries must be employed as a Lecturer at a Public TVET College with which INSETA has an MoU in 2021/22. Beneficiaries must be registered in 2021 to study a SAQA-registered qualification at NQF Level 6 – 8. The duration of study must for 12 months
Grant Amount	Maximum Capped Study Bursary Amount = R30 000.00 per learner (the award will be based on proof of fees/tuition from the institution) INSETA will pay award to TVET College and TVET College must pay amount to Institute of study on behalf of Lecturer.
Grant Amount covers	The bursary will cover only tuition fee and books to the maximum of R30 000.
Administration by TVET College Coordinator	Nomination of qualifying lecturers (beneficiaries) Submission of required beneficiaries' documents to INSETA Transferring of bursary funding to the relevant universities
