1. Purpose

The Insurance Sector Education and Training Authority (INSETA), is seeking to utilise the services of a qualifying service provider with expertise in **Editing**. The Service provider will be required to edit the INSETA Sector August 2019 Skills Plan.

The Sector Skills Plan consists of 6 chapters:

- Chapter 1 – Economic Sector Profile
- Chapter 2 – Key Skills Issues
- Chapter 3 – Occupational Shortages
- Chapter 4 – Sector Partnerships
- Chapter 5 – Seta Monitoring and Evaluation
- Chapter 6 – Strategic Skills Priority Actions

The document consists of approximately sixty (60) pages of single-sided printing

2. Scope of work:

The scope of work includes the following:

2.1. The role of the Editor will be as follows:

- a) To ensure that the August 2019 Sector Skills Plan complies with the formatting and length requirements prescribed by the SETA Support Directorate at the Department of Higher Education and Training.

Further ensure that each of the 6 chapters comply with the framework requirements as set out by the Department of Higher Education and Training. A copy of the formatting and length requirements as well as the framework requirements are attached to the back of this Request for Quotation (RFQ).

- b) To correct the Sector Skill Plan based first on the writer's goals; having either spoken or communicated extensively with them about this. These goals revolve around the following: ensuring a smooth flow of the document; rewriting executive summary; introduction; and conclusions. Also rewriting where necessary, the introduction and conclusion of each chapter.
- c) To review the shape or condition of the writing itself. Correct errors in syntax (spelling, punctuation & grammar), line edits or a proofread, with notes or observations.

- d) To review for clichéd phrases, over-used words and the overall organisation of the Sector Skills Plan.
- e) To review the facts and look at the ethical or legal issues surrounding the work to ensure that the writer has documented information correctly.
- f) The editor will have to undertake one (1) edit of the INSETA Sector Skills Plan.

The Editing of the Sector Skills Plan will require a person with the following Skills and understanding:

- Proofreading skills - looking at the syntax (spelling, punctuation and grammatical side of the work)
- Read the written content and check it for sense, clarity, grammatical and mechanical accuracy, and conformance with the prescribed standards or guidelines the writer has told them it needs to adhere to.
- Focuses on the structure and flow of the work as a whole.
- Document text, graphs, tables, figures, alignment and consistency of alignment of these with the rest of the document.

2.2. Reporting Requirements

Service Providers will be responsible for reporting progress to the INSETA at least on a weekly basis, as agreed with INSETA.

2.3. Audit Trails

The Service Provider will be required to maintain adequate audit trails of any and all written communication, minutes of meetings and financial records pertaining to the engagement with the INSETA.

2.4. Backup and Recovery

The Service Provider will be required to maintain an adequate backup of all project related documentation.

2.5. File and Record Retention

All electronically stored data, hard copy originals, and microfilm/fiche and other media are all deemed property of the INSETA and must be returned to the INSETA in a retrievable form at the termination of the contract. The INSETA and the Service Provider will develop policies and procedures for the archiving of data including format and media as well as standards on destroying material and data. While in the possession of the Service Provider, all such materials must be stored off-site in a secure room, vault or container.

2.6 Copyright

Copyright will cede with INSETA. INSETA reserves the right to use materials, by its sector, should it choose to either reappoint or extend the successful Service Provider's contract, without having to again pay for the copyrights to the applicable materials.

2.7 Appointment Termination/Cancellation Service Turnover

The successful bidder will be required to sign an INSETA contract. At the end of the contract period or termination of the agreement, if requested by the INSETA the Service Provider must provide assistance in transferring contracted operations and systems either to the INSETA itself, another

Service Provider, or a combination of these two options. This is to provide for an orderly and controlled transition to either the INSETA or a successor Service Provider.

3. Pricing Schedule:

Price quotations must be inclusive of all applicable taxes (e.g. VAT).

4. Mandatory evaluation requirement:

- a) The bidder must provide three (3) reference letters in editing research documents within the Skills Development and Finance related sectors. Reference letters must be on referring client's letterhead, signed and dated.
- b) Provide a company profile indicating that the bidder has a minimum of three (3) years' experience in editing research documents, preferably in a Skills Development and Finance related sectors.
- c) The team lead Content Writer must be in possession of a minimum of a relevant NQF-Level 6 qualification.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2017

 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder
6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
- (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
